S.B. No. 621

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the transfer of the regulation of plumbing to the Texas
3 Department of Licensing and Regulation, following recommendations
4 of the Sunset Advisory Commission; requiring an occupational
5 license; authorizing a fee.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Section 1301.002, Occupations Code, is amended
8 by amending Subdivisions (1), (1-a), (1-b), (2), (3), (4), (5),
9 (6), (8), (9), (10), and (11) and adding Subdivisions (1-c) and
10 (7-a) to read as follows:

11 (1) "Advisory board" [~~"Board"~~] means the Texas [~~State~~
12 ~~Board of~~] Plumbing Advisory Board established under Subchapter C
13 [Examiners].

14 (1-a) "Commission" means the Texas Commission of
15 Licensing and Regulation.

16 (1-b) "Control valve" means a valve that operates each
17 time water is supplied to, or shut off from, a receptacle or
18 plumbing fixture. The term does not include a stop valve that may be
19 installed in the water supply branch to the control valve.

20 (1-c) "Department" means the Texas Department of
21 Licensing and Regulation.

22 (2) [~~(1-b)~~] "Executive director" means the executive
23 director of the department [~~Texas State Board of Plumbing~~
24 ~~Examiners]~~.

1 (3) "Drain cleaning" [~~(2) "Drain cleaner"~~] means [a
2 person who]:

3 (A) installing [~~has completed at least 4,000~~
4 ~~hours working under the supervision of a responsible master plumber~~
5 ~~as a drain cleaner-restricted registrant,~~

6 [~~(B) has fulfilled the requirements of and is~~
7 ~~registered with the board, and~~

8 [~~(C) installs~~] cleanouts and removing [~~removes~~]
9 and resetting [~~resets~~] p-traps to eliminate obstructions in
10 building drains and sewers under the supervision of a [~~responsible~~]
11 master plumber; or

12 (B) clearing [~~-~~

13 [~~(3) "Drain cleaner-restricted registrant" means a~~
14 ~~person who:~~

15 [~~(A) has worked as a plumber's apprentice under~~
16 ~~the supervision of a responsible master plumber,~~

17 [~~(B) has fulfilled the requirements of and is~~
18 ~~registered with the board, and~~

19 [~~(C) clears~~] obstructions in sewer and drain
20 lines through any code-approved existing opening under the
21 supervision of a [~~responsible~~] master plumber.

22 (4) "Journeyman plumber" means a person licensed under
23 this chapter who:

24 (A) has met the qualifications for registration
25 as a plumber's apprentice or for licensing as a tradesman
26 plumber-limited license holder;

27 (B) has completed at least 8,000 hours working

1 under the supervision of a [~~responsible~~] master plumber;

2 (C) installs, changes, repairs, services, or
3 renovates plumbing or supervises any of those activities under the
4 supervision of a [~~responsible~~] master plumber;

5 (D) has passed the required examination; and

6 (E) has fulfilled the other requirements of the
7 commission [~~board~~].

8 (5) "Master plumber" means a person licensed under
9 this chapter who:

10 (A) is skilled in the design, planning, and
11 superintending of plumbing and in the practical installation,
12 repair, and servicing of plumbing;

13 (B) has worked as a journeyman plumber:

14 (i) for at least four years; or

15 (ii) for at least one year and has
16 successfully completed a training program approved by the United
17 States Department of Labor Office of Apprenticeship or another
18 nationally recognized apprentice training program accepted by the
19 commission [~~board~~];

20 (C) performs or supervises plumbing work;

21 (D) has passed the required examination; and

22 (E) has fulfilled the other requirements of the
23 commission [~~board~~].

24 (6) "Plumber's apprentice" means a person other than a
25 master plumber, journeyman plumber, or tradesman plumber-limited
26 license holder who:

27 (A) [~~7~~] as the person's principal occupation,

1 learns about and assists in the installation of plumbing, including
2 drain cleaning and residential utilities installation;

3 (B) has fulfilled the requirements of the
4 commission and is registered by the department; [~~board,~~] and

5 (C) works under the supervision of a
6 [~~responsible~~] master plumber [~~and the direct supervision of a~~
7 ~~licensed plumber~~].

8 (7-a) "Plumbing contractor" means a person licensed as
9 a plumbing contractor under this chapter who:

10 (A) is a master plumber, or employs a master
11 plumber, for the purpose of offering and performing plumbing work
12 that will be performed or supervised by the master plumber;

13 (B) is authorized to obtain permits for plumbing
14 work;

15 (C) assumes responsibility for plumbing work
16 performed for compensation paid to the person; and

17 (D) has submitted a certificate of insurance as
18 required by Section 1301.3576.

19 (8) "Plumbing inspector" means a person who:

20 (A) is employed by a political subdivision or
21 state agency, or contracts as an independent contractor with a
22 political subdivision or state agency, to inspect plumbing in
23 connection with health and safety laws, including ordinances, and
24 plumbing and gas codes;

25 (B) has passed the required examination; and

26 (C) has fulfilled the other requirements of the
27 commission [~~board~~].

1 (9) "Residential utilities installation"

2 [~~"Residential utilities installer"~~] means constructing and
3 installing [~~a person who:~~

4 [~~(A) has completed at least 2,000 hours working~~
5 ~~under the supervision of a master plumber as a plumber's~~
6 ~~apprentice;~~

7 [~~(B) has fulfilled the requirements of and is~~
8 ~~registered with the board; and~~

9 [~~(C) constructs and installs~~] yard water service
10 piping for one-family or two-family dwellings and building sewers
11 under the supervision of a [~~responsible~~] master plumber.

12 (10) "Tradesman plumber-limited license holder" means
13 a person who:

14 (A) has completed at least 4,000 hours working
15 under the [~~direct~~] supervision of a [~~journeyman or~~] master plumber
16 as a plumber's apprentice;

17 (B) has passed the required examination;

18 (C) constructs and installs plumbing for
19 one-family or two-family dwellings under general [~~the~~] supervision
20 [~~of a responsible master plumber~~]; and

21 (D) has fulfilled the other requirements of the
22 commission [~~board~~].

23 (11) "Water supply protection specialist" means a
24 person who holds an endorsement issued by the department [~~board~~] to
25 engage in:

26 (A) customer service inspections, as defined by
27 rule of the Texas Commission on Environmental Quality; and

1 (B) the installation, service, and repair of
2 plumbing associated with the treatment, use, and distribution use
3 of rainwater to supply a plumbing fixture or appliance.

4 SECTION 2. Sections 1301.056 and 1301.057, Occupations
5 Code, are amended to read as follows:

6 Sec. 1301.056. LAWN IRRIGATION SYSTEMS. A person licensed
7 by the department under this chapter [~~board~~] is not required to be
8 licensed by another board or agency to install or work on a lawn
9 irrigation system.

10 Sec. 1301.057. SELF-HELP PROJECT. (a) A person is not
11 required to be licensed under this chapter to perform plumbing,
12 limited to the provision of a residential potable water supply or
13 residential sanitary sewer connection, for a project that:

14 (1) is in a county a part of which is within 50 miles of
15 an international border; and

16 (2) is performed by an organization that:

17 (A) is certified by the Texas [~~Natural Resource~~
18 ~~Conservation~~] Commission on Environmental Quality to provide
19 self-help project assistance; and

20 (B) provides the department [~~board~~] with the
21 following information before the 30th day before the date the
22 project begins:

23 (i) the exact location of the project;

24 (ii) the intended duration of the project;

25 and

26 (iii) other information the department
27 [~~board~~] requires.

1 (b) The department [~~board~~] may require under Subsection
2 (a)(2)(B)(iii) that the organization provide a post-construction
3 report signed by a plumbing inspector stating that the plumbing is
4 safe.

5 (c) The department [~~board~~] may provide training to an
6 organization that provides self-help project assistance under this
7 section.

8 SECTION 3. The heading to Subchapter C, Chapter 1301,
9 Occupations Code, is amended to read as follows:

10 SUBCHAPTER C. TEXAS [~~STATE BOARD OF~~] PLUMBING ADVISORY BOARD
11 [~~EXAMINERS~~]

12 SECTION 4. Section 1301.151, Occupations Code, is amended
13 to read as follows:

14 Sec. 1301.151. TEXAS [~~STATE BOARD OF~~] PLUMBING ADVISORY
15 BOARD [~~EXAMINERS~~] MEMBERSHIP. (a) The Texas [~~State Board of~~]
16 Plumbing Advisory Board [~~Examiners~~] consists of nine members
17 appointed by the presiding officer of the commission, with
18 commission approval, [~~governor with the advice and consent of the~~
19 ~~senate~~] as follows:

20 (1) one member who has at least 10 years' practical
21 experience and is licensed as a master plumber;

22 (2) one member who has at least five years' practical
23 experience and is licensed as a journeyman plumber;

24 (3) one member who has at least five years' practical
25 experience and is licensed as a plumbing inspector;

26 (4) one member who is [~~has been~~] a plumbing contractor
27 [~~responsible master plumber for at least five years with at least 10~~

1 ~~years' experience as a licensed journeyman plumber or master~~
2 ~~plumber];~~

3 (5) one member who is a licensed engineer practicing
4 in the field of plumbing engineering;

5 (6) two members who are building contractors with at
6 least five years' contracting experience, one of whom is
7 principally engaged in home building and one of whom is principally
8 engaged in commercial building; ~~and]~~

9 (7) one member who is a licensed plumber; and

10 (8) one member ~~[two members]~~ who represents
11 ~~[represent]~~ the public.

12 (b) Each member of the advisory board must be a United
13 States citizen.

14 (c) Appointments to the advisory board shall be made without
15 regard to the race, color, disability, sex, religion, age, or
16 national origin of the appointee.

17 (d) Chapter 2110, Government Code, does not apply to the
18 composition or duration of the advisory board or to the appointment
19 of the advisory board's presiding officer.

20 SECTION 5. Section 1301.152, Occupations Code, is amended
21 to read as follows:

22 Sec. 1301.152. ELIGIBILITY OF PUBLIC MEMBER ~~[MEMBERS]~~. A
23 person is not eligible for appointment as a public member of the
24 advisory board if the person or the person's spouse:

25 (1) is licensed by an occupational regulatory agency
26 in the building construction industry;

27 (2) is employed by or participates in the management

1 of an agency or business entity related to the building
2 construction industry; or

3 (3) has, other than as a consumer, a financial
4 interest in a business entity related to the building construction
5 industry.

6 SECTION 6. Section 1301.154, Occupations Code, is amended
7 to read as follows:

8 Sec. 1301.154. TERMS. Advisory board [~~Board~~] members serve
9 staggered six-year terms.

10 SECTION 7. Section 1301.157, Occupations Code, is amended
11 to read as follows:

12 Sec. 1301.157. OFFICER [~~OFFICERS~~]. [~~(a)~~] The presiding
13 officer of the commission [~~governor~~] shall designate a member of
14 the advisory board as the presiding officer of the board to serve in
15 that capacity at the pleasure of the presiding officer of the
16 commission [~~governor~~].

17 [~~(b) The board shall elect a secretary from its membership.~~]

18 SECTION 8. Section 1301.158, Occupations Code, is amended
19 to read as follows:

20 Sec. 1301.158. COMPENSATION [~~PER DIEM; REIMBURSEMENT~~]. An
21 advisory [~~(a) A~~] board member may not receive compensation [~~a fixed~~
22 ~~salary~~] for service on the advisory board.

23 [~~(b) A board member is entitled to receive a per diem as set~~
24 ~~by the General Appropriations Act for each day the member engages in~~
25 ~~the business of the board.~~]

26 [~~(c) A board member may not receive reimbursement for travel~~
27 ~~expenses, including expenses for meals and lodging, other than~~]

1 ~~transportation expenses. A member is entitled to reimbursement for~~
2 ~~transportation expenses as provided by the General Appropriations~~
3 ~~Act.]~~

4 SECTION 9. Subchapter C, Chapter 1301, Occupations Code, is
5 amended by adding Section 1301.160 to read as follows:

6 Sec. 1301.160. DUTIES OF ADVISORY BOARD. The advisory
7 board shall provide advice and recommendations to the department on
8 technical matters relevant to the administration and enforcement of
9 this chapter, including examinations, licensing qualifications,
10 plumbing code requirements, and continuing education requirements.

11 SECTION 10. The heading to Subchapter D, Chapter 1301,
12 Occupations Code, is amended to read as follows:

13 SUBCHAPTER D. DEPARTMENT [~~EXECUTIVE DIRECTOR AND OTHER BOARD~~]
14 PERSONNEL

15 SECTION 11. Section 1301.202, Occupations Code, is amended
16 to read as follows:

17 Sec. 1301.202. CERTAIN PLUMBING EXAMINERS [~~EXAMINER~~]. (a)
18 If an examination required for the issuance of a license,
19 endorsement, or certificate of registration under this chapter
20 contains a practical component, the department [~~The board~~] shall
21 employ or contract with one or more plumbing examiners to
22 administer that portion of the examination. [~~A plumbing examiner~~
23 ~~serves at the will of the board.~~] A plumbing examiner must:

24 (1) hold a license as a plumber issued under this
25 chapter; and

26 (2) be knowledgeable of this chapter and municipal
27 ordinances relating to plumbing[~~, and~~

1 ~~[(3) be qualified by experience and training in~~
2 ~~plumbing practice].~~

3 (b) A plumbing examiner shall:

4 (1) examine the fitness and qualifications of a person
5 applying to the department ~~[board]~~ for a license as a master

7 holder, or plumbing inspector; and

8 (2) promptly certify the result of the examination to
9 the department ~~[board]~~.

10 SECTION 12. Section 1301.203, Occupations Code, is amended
11 to read as follows:

12 Sec. 1301.203. FIELD REPRESENTATIVE; INSPECTIONS. (a) The
13 department ~~[board]~~ may employ a field representative to assist the
14 department ~~[board]~~ in enforcing this chapter and rules adopted
15 under this chapter. A field representative must [+

16 ~~[(1) hold a license as a plumber under this chapter,~~
17 ~~[(2)]~~ be knowledgeable of this chapter and municipal
18 ordinances relating to plumbing[+, and

19 ~~[(3) be qualified by experience and training in~~

21 (b) A field representative may:

22 (1) conduct on-site license checks to determine
23 compliance with this chapter;

24 (2) investigate consumer complaints [~~filed under~~

26 (3) assist municipal plumbing inspectors in enforcing
27 this chapter[+]

9 SECTION 13. The heading to Subchapter E, Chapter 1301,
10 Occupations Code, is amended to read as follows:

12 SECTION 14. Sections 1301.251 and 1301.253, Occupations
13 Code, are amended to read as follows:

14 Sec. 1301.251. GENERAL DUTIES ~~[OF BOARD]~~. The executive
15 director or commission, as appropriate, [board] shall:

16 (1) administer this chapter; and

17 (2) adopt and enforce rules necessary to administer
18 this chapter, including requirements for the issuance and renewal
19 of a license, endorsement, or certificate of registration under
20 this chapter~~, and~~

21 ~~[(3) keep a record of each proceeding conducted before~~
22 ~~and action taken by the board].~~

23 Sec. 1301.253. FEES. The commission ~~[board]~~ shall set fees
24 under this chapter in amounts that are reasonable and necessary to

26 SECTION 15. Sections 1301.255(a), (b), (c), and (d),
27 Occupations Code, are amended to read as follows:

2 plumbing codes, as those codes existed on May 31, 2001:

3 (1) the Uniform Plumbing Code, as published by the
4 International Association of Plumbing and Mechanical Officials;
5 and

6 (2) the International Plumbing Code, as published by
7 the International Code Council.

8 (b) The commission [~~board~~] by rule may adopt later editions
9 of the plumbing codes listed in Subsection (a).

10 (c) Plumbing installed in an area not otherwise subject to
11 regulation under this chapter by a person licensed under this
12 chapter must be installed in accordance with a plumbing code
13 adopted by the commission [~~board~~] under Subsection (a) or (b).

14 (d) In adopting a code for the design, installation, and
15 maintenance of a plumbing system under this section, a municipality
16 or an owner of a public water system may amend any provisions of the
17 code to conform to local concerns that do not substantially vary
18 from commission [~~board~~] rules or other rules of this state.

19 SECTION 16. Section 1301.262, Occupations Code, is amended
20 to read as follows:

21 Sec. 1301.262. CODES [~~PLUMBING INSPECTOR CODE~~] OF CONDUCT.

22 (a) The commission [~~board~~] by rule shall establish a code of
23 conduct for licensed plumbing inspectors. The code of conduct
24 shall require a plumbing inspector to enforce this chapter and
25 commission [~~board~~] rules in a consistent manner across job sites.

26 (b) The commission by rule may establish standards of
27 conduct for a holder of a license, endorsement, or certificate of

1 registration issued under this chapter.

2 SECTION 17. Subchapter E, Chapter 1301, Occupations Code,
3 is amended by adding Section 1301.263 to read as follows:

4 Sec. 1301.263. EXAMINATION ADMINISTRATION AND CONTENT. (a)
5 The department shall recognize, prepare, administer, or arrange for
6 the administration of an examination required by this chapter.

7 (b) The department shall determine the minimum requirements
8 and passing score for an examination required by this chapter.

9 (c) If an examination required by this chapter contains a
10 practical component, the practical component must be administered
11 by a plumbing examiner as provided by Section 1301.202.

12 SECTION 18. The heading to Subchapter F, Chapter 1301,
13 Occupations Code, is amended to read as follows:

14 SUBCHAPTER F. PRACTICE BY LICENSE HOLDER [~~CONSUMER INTEREST~~
15 ~~INFORMATION AND COMPLAINT PROCEDURES~~]

16 SECTION 19. Section 1301.302, Occupations Code, is amended
17 to read as follows:

18 Sec. 1301.302. CONTRACT INFORMATION; REQUIRED DOCUMENTS. A
19 written proposal, invoice, or contract relating to plumbing
20 services performed by or under the direction of a plumber licensed
21 under this chapter must contain the name and license number of the
22 plumbing contractor [~~responsible master plumber~~] and the name,
23 mailing address, and telephone number of the department [~~board~~].
24 The person who performed the services shall give the customer an
25 invoice or completed contract document on completion of the job,
26 regardless of whether the person charged a fee for performing the
27 services.

1 SECTION 20. Subchapter F, Chapter 1301, Occupations Code,
2 is amended by adding Section 1301.305 to read as follows:

3 Sec. 1301.305. SUPERVISION RULES; RESPONSIBILITY FOR
4 PLUMBING WORK. (a) The commission by rule shall:

5 (1) require that, for each task involved in plumbing,
6 a master plumber:

7 (A) perform the task; or

8 (B) provide general or direct supervision of a
9 less experienced plumber who performs the task;

10 (2) require that each plumber's apprentice and
11 tradesman plumber-limited license holder perform plumbing under
12 the direct or general supervision of a more experienced plumber;

13 (3) specify the plumbing tasks that a plumber's
14 apprentice or tradesman plumber-limited license holder must
15 perform under direct supervision and the plumbing tasks a plumber's
16 apprentice or tradesman plumber-limited license holder must
17 perform under general supervision;

18 (4) specify the amount of classroom training meeting
19 the requirements of Subsection (b), practical plumbing experience,
20 or a combination of that training and experience necessary to:

21 (A) exempt a plumber from the direct supervision
22 requirements under this section; and

23 (B) permit the plumber to perform the plumbing
24 under general supervision;

25 (5) require a plumber, other than a master plumber, to
26 document the plumber's:

27 (A) classroom training that meets the

1 requirements of Subsection (b); and

2 (B) practical plumbing experience; and

3 (6) require the plumbing contractor, and supervising
4 plumber, if any, to assume responsibility for plumbing performed,
5 including the quality of the plumbing and the supervision of less
6 experienced plumbers.

7 (b) Notwithstanding the minimum requirements for a
8 continuing education program or instructor established under this
9 chapter, the commission by rule shall establish minimum
10 requirements for classroom training, other than a continuing
11 education program under this chapter, that, if successfully
12 completed and documented by a plumber, the department shall credit
13 toward:

14 (1) the necessary classroom training required to:

15 (A) exempt the plumber from the direct
16 supervision requirements under this section; and

17 (B) permit the plumber to perform specified
18 plumbing tasks under general supervision;

19 (2) the continuing education required under this
20 chapter to renew a license, endorsement, or certificate of
21 registration, as applicable to the plumber; and

22 (3) the eligibility requirements for a license under
23 this chapter, as applicable to the plumber.

24 SECTION 21. Sections 1301.351(a), (a-1), and (c),
25 Occupations Code, are amended to read as follows:

26 (a) A person [~~other than a responsible master plumber,~~] may
27 not perform or offer to perform [~~engage in~~] plumbing for

1 compensation unless:

2 (1) the person holds:

3 (A) a plumbing contractor license; and

4 (B) the proper license, endorsement, or
5 certificate of registration~~[, or endorsement]~~ required by this
6 chapter to perform or supervise the performance of plumbing; and

7 (2) the person:

8 (A) is employed by a plumbing contractor;

9 (B) performs or supervises the plumbing on behalf
10 of the plumbing contractor; and

11 (C) holds the proper license, endorsement, or
12 certificate of registration required by this chapter; or

13 (3) the person offers to perform plumbing and
14 contracts with a plumbing contractor for the performance of the
15 plumbing ~~[the person's work is supervised and controlled by a~~
16 ~~person licensed under this chapter].~~

17 (a-1) A person may not act as a plumbing contractor
18 ~~[responsible master plumber]~~ unless the person holds the
19 appropriate license and meets the applicable requirements ~~[for a~~
20 ~~responsible master plumber]~~ under this chapter.

21 (c) A plumbing contractor ~~[license holder]~~ who is
22 supervising and controlling ~~[under Subsection (a)(2)]~~ the work of a
23 person engaged in the business of plumbing in the construction of a
24 new one-family or two-family dwelling in an unincorporated area of
25 the state must have training and management responsibility for, and
26 shall review and inspect, the person's work. The plumbing
27 contractor ~~[license holder]~~ is not required to provide continuous

1 or uninterrupted on-the-job oversight of the person's work.

2 SECTION 22. Subchapter G, Chapter 1301, Occupations Code,
3 is amended by adding Section 1301.3515 to read as follows:

4 Sec. 1301.3515. CRIMINAL HISTORY RECORD INFORMATION FOR
5 LICENSE ISSUANCE. (a) The department shall require that an
6 applicant for a license submit a complete and legible set of
7 fingerprints, on a form prescribed by the executive director, to
8 the department or to the Department of Public Safety for the purpose
9 of obtaining criminal history record information from the
10 Department of Public Safety and the Federal Bureau of
11 Investigation.

12 (b) The department may not issue a license to a person who
13 does not comply with the requirement of Subsection (a).

14 (c) The department shall conduct a criminal history record
15 information check of each applicant for a license using
16 information:

17 (1) provided by the individual under this section; and

18 (2) made available to the department by the Department
19 of Public Safety, the Federal Bureau of Investigation, and any
20 other criminal justice agency under Chapter 411, Government Code.

21 (d) The department may:

22 (1) enter into an agreement with the Department of
23 Public Safety to administer a criminal history record information
24 check required under this section; and

25 (2) authorize the Department of Public Safety to
26 collect from each applicant the costs incurred by the Department of
27 Public Safety in conducting the criminal history record information

1 check.

2 SECTION 23. Section 1301.352, Occupations Code, is amended
3 to read as follows:

4 Sec. 1301.352. EXAMINATION REQUIRED. The department
5 [~~board~~] shall issue a license or endorsement as a master plumber,
6 journeyman plumber, plumbing inspector, tradesman plumber-limited
7 license holder, medical gas piping installation endorsement
8 holder, water supply protection specialist, or multipurpose
9 residential fire protection sprinkler specialist to a person who
10 demonstrates the fitness, competence, and qualifications to
11 receive the license or endorsement by passing a uniform, reasonable
12 examination.

13 SECTION 24. Section 1301.3522, Occupations Code, is amended
14 to read as follows:
